GABC Board Member Profile: Gerhard Schneiders Principal, Rödl & Partner Rödl Langford de Kock LLP



What's your connection with German-American business?

Frank: For many years I had the fortune to work for U.S. organizations and businesses in Germany. Now that I'm back in the states (since 2010) I find it rewarding to make the connection the other way around, namely with German businesses in the U.S. as well as those U.S. businesses that maintain a strong presence in Germany and elsewhere in Europe.

What do you like about the GABC?

Frank: What I enjoy most about the GABC is the balanced variety and quality of the events, from sophisticated business presentations and economic outlooks to social gatherings and cultural events that promote a convivial exchange and always in a very nice atmosphere. More selfishly, I also enjoy the chance to use my German. While many Germans speak English very well, it's less common for Americans to speak German and I'd like to keep that ability.

What are you looking forward to seeing the GABC do in the future?

Frank: In addition to a continuation of the kind of events the GABC already conducts so well, there are two things I'd love to hear more about:

What's your connection with German-American business?

Gerhard: My firm and I successfully advise and serve German-speaking (and other European) companies in the U.S. in the areas of auditing, accounting, tax or consulting. We are bilingual and have profound knowledge about rules and regulations to be applied on both sides of the ocean. I am traveling frequently back to Germany and Europe to visit existing or find new clients.

What do you like about the GABC?

Gerhard: It's a great networking group, steadily growing and adding new members. I really like when members open their doors and host on site events.

What are you looking forward to seeing the GABC do in the future?

• Germany's demographic shift (population growth projections) in comparison with the rest of Europe and the U.S. I find this very significant and worthy of comparative discussion.

Tell us something about yourself that we wouldn't know by looking at your CV.

When I returned to the U.S., I was living in Silicon Valley but determined to get back to New England to be closer to family. I made some exploratory trips to the Boston area and registered for a networking event hosted by the GABC Boston.

Konditor Meister is an exquisite bakerv that pays homage to the European traditions of pastry arts. The success of Konditor Meister originates with chef/owner Günther Mösinger, a creative and passionate pastry chef who knew from an early age that his career would take a culinary path. Born on a farm in the beautiful historic town of Freiburg in the Black Forest, he learned early on how to grow and prepare foods for daily living. When he was only 12, Günther had his first job as a delivery boy bringing rolls to people's houses with the bike. At 14, he started his education to become a Konditor Meister. After seven years of schooling and practice in the finest Hotels and Cafes in Freiburg, he earned his title.

In 1981 Günther moved to Boston Massachusetts and worked at the Ritz Carlton. Despite no English language skills, he impressed the other chefs. Very strict and demanding, he made sure things got done right the first time. Here famous chefs like Julia Child and politicians like the Kennedys enjoyed Günther's fancy desserts and cakes. In 1985, after only four years at the Ritz, he decided to set up his own shop "Konditor Meister" in Quincy Massachusetts. The business was so successful that he had to move to a bigger location after ten years. At the new location in Braintree, business continued to go strong. Konditor Meister was nationally recognized by the Today Show and made Best of Boston and Best of the Knot in New England.

German Program at Boston Latin Saved



German has been a long-standing tradition at the Boston Latin School (BLS), but has had to work hard in recent years to entice students away from other languages. Last year, the program faced being eliminated from their Modern Foreign Language program due to low enrollment, and German 1 was not offered. A group of determined parents with connections in the German American community and a love of German banded together to work with the school this year to help revive the program. German received extra attention at parent nights and fundraisers, students were given fliers extolling the benefits of German, and the various language clubs sponsored an informational fair after school so that students could talk to their peers about making the best language choice.

As a result of their campaign to provide more education and awareness for students making their language choices at the end of 7th grade, BLS was thrilled to have at least 70 students signed up for German 1 next year! BLS will also offer one section each of German 3 and German 4.

Boston Latin School's goal is to make the program sustainable, and continue to provide opportunities for their German students to help increase their global and cultural awareness. In recent years, BLS students have earned gold, silver and bronze medals in the **National German Exam** and 5s on the **Advanced Placement** exam. Two students have been chosen for the AATG/Paedogo-gischer Austauschdienst Study Trip.
