Hello and surprise! It's Marian greeting you in this month's newsletter instead of our fearless leader Erik Dilger. At the request of members who heard my speech at the gala, I humbly provide a version of that here:

Although I know most of you, many of you don't know each other—yet. But whether you realize it or not, you have a deep, cultural and emotional connection that only those of us who span the two cultures of Germany and the States truly understand.

Just about every person in this room tonight knows what it feels like to straddle the two worlds, to struggle with cultural identity. Or is close to someone who does. When I'm in Germany, I feel American. When I'm in the States, I feel European. Many of you thought you were coming to the States for a 2-year adventure, never dreaming you'd stay. But then...the job was extended.... Or you married an American.... Or you had children with American passports who go through a different gate than you at customs---did you ever imagine that? And suddenly the 2 years became 5 years, and then what? Stay? Go?

What about the Americans like myself that feel they were only born in the States by sheer chance? I am ethnic German and Dutch. I don't have an ounce of American blood in me. I was raised on Rotkohl and Schwarzbrot. When I lived in Germany, I passed myself off as German.

When someone asks you where HOME is, what do you say? Is there a hesitation? Is it where your business is, where your parents are? Where your partner is? Where your apartment is? Or is it where you FEEL LIKE YOUR TRUE SELF.

GABC tries to create a community where both Germans and Americans that share these histories of cultural identity can find each other. We can talk to each in shortcut. We don't have to explain things. We GET it. We KNOW. You think you don't know each other—but you do.

So today, wherever you call HOME, let's just celebrate that we can attend events together and meet from time to time in this beautiful city of Boston, which isn't ALWAYS buried in snow, with a shared thread of cultural identity that binds us together. Please reach out to each other—exchange cards, stay in touch after meeting other members at events. These are the connections that can enrich us.



MIT Media Lab: Creating Disruptive Technologies



(March 12, 2015) — GABC members and guests attended a reception, presentation and tour of MIT's world renowned Media Lab in Cambridge, MA. Actively promoting a unique, anti-disciplinary culture, the MIT Media Lab goes beyond known boundaries and disciplines, creating disruptive technologies that happen at the edges. Our presenter Kent Larson directs the City Science Initiative and the Changing Places Group, one of over 20 research groups at the MIT Media Lab. His projects include advanced simulation and augmented reality for urban design, transformable urban housing, mobility-on-demand systems, and new vehicles as alternatives to the private automobile. His group is committed to living lab deployments that test and evaluate urban innovation in real-world environments. Kent is currently exploring collaborations with the city of Hamburg, Germany and welcoming the interest and funding of German companies.

Tips for Expanding Your European Enterprise to Massachusetts: How Menck Windows'

Manufacturing Facility got Up and Running in Central MA:

It's been about a year and half since we made the decision to locate our new company, Menck Windows, here in Chicopee, Massachusetts. As reported in last March's GABC Newsletter, Menck Windows is a joint venture between Liesenfeld International and Menck Fenster GmbH of Hamburg, Germany. Company Chairman Bodo Liesenfeld established the company in 2013. Menck USA was established to bring the best in German window and door technology, as well as the best in German production technology, here to the United States.

Now both Menck Fenster and Menck Windows (a U.S. Corporation) are producing finely-crafted, precision manufactured, windows, doors and curtain walls; these fenestration products represent some of the best performing, energy-efficient, fenestration products to be found on either side of the Atlantic.

Why did we decide to establish our company in Chicopee, Massachusetts?

Western Massachusetts, and the Greater Springfield and Pioneer Valley in particular, was quick to rise to the top of our possible locations list. Among the factors influencing our decision were the following. The intersection of Interstate 91 and Interstate 90 make for easy north-south and easy east-west transportation, transportation of both incoming materials and outgoing product. The area has a history of manufacturing and, in particular, precision manufacturing. There are, within 500 miles of our headquarters and manufacturing plant, a North American population of nearly 100 million people.

As to how it was that we were able to get our new plant up and running in little more than a year?

Credit goes to a number of Massachusetts development entities that helped us to make vision into a reality. MassEcon provided us with a list of developable land and existing buildings here in the Commonwealth, various properties that would provide Menck suitable space for our new manufacturing plant. MassDevelopment provided us with two critically important financing tools: a tax exempt bond program and a loan guarantee program. These programs enabled Menck to borrow money for plant and equipment at a fixed rate of under 4%. Last but not least, the Chicopee City Council and the Massachusetts Office of Business Development worked together to provide Menck with nearly \$1 million in economic development incentives: the City by way of a Special Tax Assessment Agreement and the Office of Business Development by way of an Economic Development Incentive Program or EDIP Agreement.

A heartfelt thanks to all of the economic development professionals who helped Menck to, very quickly and cost-effectively, get up and running here in Chicopee. We urge other German companies looking to expand here in Massachusetts to avail themselves of this development assistance and these development tools.

We look forward to making products here in the Commonwealth—for better buildings and thus a better world—for years to come!

Board Member-at-Large Profile: Angelo Moesslang, PhD Chief Financial Officer Fresenius Medical Care NA



What's your connection with German-American business?

Angelo: We moved to Boston in 2010 but I had exposure to the U.S. before. The company I work for managed to acquire a U.S. business double its size back in the mid 90's. As one of my first jobs I was lucky enough to be on the project team for this transaction which created Fresenius Medical Care. We are a globally active German healthcare group caring for patients that have lost their kidney function. The U.S. business is the biggest of all worldwide subsidiaries and generates in excess of \$10 billion of revenues and employs more than 55,000 people. It was exciting for me to be appointed CFO of the U.S business, almost 15 years after my first business trip to the U.S. and 25 years after spending a few nice summers in Washington State as student.

What do you like about the GABC?

Angelo: A lot! The people, the idea, the events, the network. GABC has a nice mix of being reminded of the connection to Germany but at the same time I feel that the members do not try to pretend that we are in Germany. Everyone I met at GABC seems to have a connection or interest that is somehow shared and that touches both sides of the Atlantic.

What are you looking forward to seeing the GABC do in the future?

Angelo: I believe that GABC is pretty uniquely positioned in Boston when it comes to connecting our community. As a self-funded Council we are able to offer attractive events and connections that are tailored to the members, both private and corporate. I think the Board, the Executive Director and all active members have built a very nice platform in the past years that can be expanded even further.

What keeps you busy when you're not working?

Angelo: As most of us I am plenty busy at work—so not being busy outside of work is occasionally the goal to be honest. Often we simply enjoy living in the City, meeting up with friends, exploring New England and going biking or running along the Esplanade.

Tell us something about yourself that we wouldn't know by looking at your CV.

Angelo: As a student in Munich I spent a good part of the winters skiing, summers sailing, and year-round working as a sound engineer for events and occasionally as a DJ — with hindsight it seems a bit surprising I ended up with a degree.

What's your connection with German-American business?

Ed: As an attorney specialized in intellectual property-patents, trademarks, and copyright, Germany is a major partner for trade and technology transfer for the clients and businesses I support. For much of my career as in-house patent counsel, I've worked directly with both Germany-headquartered business having a major U.S. subsidiary as well as U.S-headquartered business having a major German subsidiary. Having worked long-term in both countries helps me to better provide guidance (in both languages) on global planning for intelligent risk assessment; to better turn the fruits of R&D into protectable assets that justify a premium market position; and to better build bridges between American and German legal and patent-legal analysis.

What do you like about the GABC?

Ed: That this volunteer-driven organization is so dynamic, and leverages local resources just as well as it attracts visitors or VIPs from abroad. This reminds members that

we learn from each other and have a hand in building our group.

What are you looking forward to seeing the GABC do in the future?

Ed: Encourage more Members' companies to host events, and continue on the path of growing the membership to include more local business partners of German-based enterprises.

What keeps you busy when not working?

Ed: I like to have at least two sports for every season (which lately meant doubling down on winter sports), and enjoy climbing, hiking, and sailing; also theater, reading, live music, and volunteering.

German Saturday School: Testing Season and Registration Opens

Shortly after 9:00 AM on Saturday mornings, the Diamond Middle School in Lexington, MA starts buzzing when it turns from a public middle school into a bustling German School. Out of nowhere there is a fully-stocked German library set up in the cafeteria with friendly parents at check-out tables; teachers checking in with the "Sekretariat"; kids, ages 4 to 16—(some sporting their favorite German soccer player jerseys) dispersing into 34 classrooms; while the aroma of "Dallmayr ProDomo" Filterkaffee lures parents to the "Kaffee-Ecke" for a relaxing morning chat.

It's also testing season for students in the upper grades. This past January, 120 students took the AATG National German exam; with 13 students completing the grueling *Deutsche Sprachdiplom* (better known as "DSD") Level II exam, among the largest number of candidates the school has seen in some years.

This March and April, more than 40 students will tackle the *Internationale Vergleichsarbeit* and DSD I. These exams are developed by the *Zentralstelle für Auslandsschulwesen* (ZfA) and include not only a written, but also an individual "oral" or "speaking" part in front of an examiner—something that is common practice in Germany, but unusual here.

On May 16, faculty, students and parents will celebrate the end of the school year with their traditional outdoor "Abschlussfeier" on the large grounds of the Boylston Schul-Verein in Walpole (the school's parent organization) with performances, presentations of diplomas and a popular family picnic.
